Official Rules: 2025

Giveaway is offered at Vitalant donor centers and mobile blood drives located across the United States of America.

May 1, 2025 – May 31, 2025

Official Rules:

The giveaway is sponsored by Vitalant, a 501(c) tax-exempt charitable organization.

Eligibility:

The giveaway is open to United States residents, who are at least 21 years of age on the date of the selection of the grand prize winner, who present to give blood at any Vitalant donor center or mobile blood drive from May 1, 2025 – May 31, 2025 (“Giveaway Period”).

Employees of Vitalant or their subsidiaries and their immediate family members, are not eligible to enter. The term “immediate family” includes spouses, siblings, parents, children, grandparents, grandchildren and other persons residing in the same household (related or not). The giveaway is void where prohibited. Residents of jurisdictions where this promotion is not permitted, or where Vitalant would be required to register or be restricted in any other way, are not eligible to win a prize.

How to Enter: Persons presenting to donate at a participating Vitalant donation location May 1, 2025 - May 31, 2025 (“Giveaway Period”), are eligible to enter the giveaway.

Donor Entry: Persons intending to donate blood, platelets or plasma must complete a donor eligibility interview to enter the giveaway during the Giveaway Period. Persons who have completed the donor eligibility interviews will be automatically entered in the giveaway. It is the responsibility of the person intending to donate to ensure that Vitalant has the correct contact phone number and email address in the event their name is drawn as the grand prize winner. Persons who do not wish to be automatically entered into the giveaway may call 877-258-4825 and press 2 for Customer Care. They can leave their name, phone number and date of donor eligibility interview to be removed from the giveaway. Only one donation entry is permitted per person per day, up to five (5) times during the promotional period.

Non-Donor Entry: No purchase or blood donation is required to enter the giveaway or to win a prize. Persons not intending to donate may call 925-732-4380 and request to be entered into the giveaway during the Giveaway Period. Only one non-donation entry is permitted per person per day, up to five (5) times during the promotional period.

Grand Prize: A maximum prize of one (1) vacation package that includes a prepaid electronic gift card valued at \$2,500, travel voucher that includes round trip airfare and hotel accommodations in Orlando, Florida, and (4) Four Universal Epic Universe Park tickets, valued at approximately Twelve Thousand Five Hundred Dollars and No Cents (\$12,500.00) will be awarded to two (2) Grand Prize Winners. The travel voucher may be spent on airfare, hotel accommodation, or entertainment up to \$10,000 total.

Selection of Grand Prize Winners: The grand prize drawing will be conducted by the Vitalant corporate office under the supervision of three employees, whose decisions are final and binding. The Winner will be selected as follows: All eligible entries, including donor and non-donor entries, received during the Giveaway Period will be combined and two (2) potential prize winners will be selected in a random drawing on or about June 5, 2025. All entries are non-transferable. The potential prize winners will be notified using the email address and phone number provided with entry on or around June 5, 2025, and may be awarded the prize subject to verification of eligibility and compliance with the terms of these

Official Rules. Prize will be fulfilled by a third-party vendor, AmTrav. Additional terms and conditions of third-party vendor may apply. Any information provided to a third-party vendor for purposes of prize fulfillment will be subjected to third-party vendor's privacy policy (<https://www.amtrav.com/privacy-policy>). Failure by the potential prize winners to respond within seventy-two (72) hours of notification and after the second of two (2) attempts will result in disqualification and an alternate potential prize winner then will be selected in the same manner, from all remaining eligible entries. If Vitalant is unable to determine and verify a potential prize winner after repeated alternate drawings, Vitalant reserves the right to not award all prize(s) or all elements of the Prize. No prize in the giveaway will be given in cash or may be redeemable or convertible into cash. Travel voucher package includes airfare, hotel accommodation, Universal Epic Universe Park tickets, and itinerary. Electronic gift cards will be emailed within forty-eight hours of prize acceptance. The travel voucher must be claimed within 60 days of acceptance, with travel dates determined by winner.

Noncompliance with any of the foregoing may result in disqualification and the selection of an alternate grand prize winner name. Vitalant reserves the right to permanently disqualify any person who it believes has intentionally violated these Official Rules.

Miscellaneous: The odds of winning depend upon the number of eligible entries received according to the eligibility requirements. By entering, participants agree to be bound by these Official Rules and decisions of Vitalant. By participating in the giveaway, participants agree to release and hold Vitalant and their employees harmless from any and all losses, damages, rights, claims and actions of any kind in connection with the drawing or the giveaway, or resulting from acceptance, possession or use of any prize, including without limitation, personal injuries, death and property damage, and claims based on publicity rights, defamation or invasions of privacy. The prize winner agrees to pay any and all taxes and other fees, which may be due as a result of winning the prize. The winner will receive a Form 1099 reflecting the value of the prize and a copy of the Form 1099 will also be sent to the Internal Revenue Service. Vitalant reserves the right to change these Official Rules without notice. Vitalant will follow the applicable laws for conducting a giveaway.
