“Rev Up the Excitement” Summer Car Giveaway

1 – Up to \$30,000 Value for Purchase of Vehicle

Official Rules: 2026

Giveaway is offered at Vitalant donor centers and mobile blood drives located across the United States of America.

July 9, 2026 – August 8, 2026

Official Rules:

The giveaway is sponsored by Vitalant, a 501(c) tax-exempt charitable organization.

Eligibility:

The giveaway is open to United States residents, who are at least 18 years of age on the date of the selection of the grand prize winner, who present to give blood at any Vitalant donor center or mobile blood drive or who host and complete an on-site blood drive or who otherwise enters the giveaway, from July 9, 2026 – August 8, 2026 (“Giveaway Period”).

Employees of Vitalant or their subsidiaries and their immediate family members, are not eligible to enter. The term “immediate family” includes spouses, siblings, parents, children, grandparents, grandchildren and other persons residing in the same household (related or not). The giveaway is void where prohibited. Residents of jurisdictions where this promotion is not permitted, or where Vitalant would be required to register or be restricted in any other way, are not eligible to win a prize.

How to Enter: Persons presenting at a participating Vitalant donation location, or who otherwise enters, during the Giveaway Period, are eligible to enter the giveaway.

Donor Entry: Persons intending to donate blood, platelets or plasma must complete a donor eligibility interview to enter the giveaway during the Giveaway Period. Persons who have completed the donor eligibility interviews will be automatically entered into the giveaway. It is the responsibility of the person intending to donate to ensure that Vitalant has the correct contact phone number and email address in the event their name is drawn as the grand prize winner. Persons who do not wish to be automatically entered into the giveaway may call 925-732-4380 for Customer Care. They can leave their name, phone number and date of donor eligibility interview to be removed from the giveaway. Only one donor eligibility interview is permitted per person per day, up to four (4) times during the promotional period.

Blood Drive Coordinator Entry: Persons who serve as the primary drive contact and who host and complete an on-site mobile blood drive during the Giveaway Period. It is the responsibility of the primary drive contact hosting a mobile blood drive to ensure that their Vitalant representative has the correct contact phone number and email address in the event their name is drawn as the grand prize winner. Persons who do not wish to be automatically entered into the giveaway may call 925-732-4380 for Customer Care. They can leave their name, phone number, blood drive name and date to be removed from the giveaway. Virtual blood drive hosts do not qualify for entry into the giveaway.

Non-Donor Entry: No purchase or blood donation is required to enter the giveaway or to win a prize. Persons not intending to donate (non-donors) may call 925-732-4380 and request to be entered into the giveaway. All requests for non-donor entries must be received no later than August 8, 2026. All entries are non-transferable. Only one non-donation entry is permitted per person per day, up to four (4) times during the promotional period.

Grand Prize: A maximum prize of the value of one (1) vehicle, in an amount not to exceed Thirty Thousand Dollars and No Cents (\$30,000.00) will be paid to the winner's chosen dealership. After the winner selects a vehicle, the dealership will provide Vitalant with a bill of sale that sets forth the total purchase price and also includes taxes, license, registration and other fees as separate line items. Vitalant will work with the dealership to determine the timing of release of the funds to the dealership for the purchase of the selected vehicle. If the purchase price of the selected vehicle is less than \$30,000.00, the winner is not entitled to any repayment or cash back of the full prize amount. If the purchase price of the selected vehicle exceeds \$30,000, then the full prize amount will be provided to the dealership, and the winner is responsible for payment of any amounts in excess of \$30,000.00. The winner is responsible for payment of all taxes, license, registration, other fees, and associated expenses. The winner is responsible for all transportation costs, if any, of the chosen dealership for delivery of the selected vehicle to a desired location.

Selection of Grand Prize Winner: The grand prize drawing will be conducted by the Vitalant corporate office under the supervision of three employees, whose decisions are final and binding. The winner will be selected as follows: All eligible entries, including non-donor entries, received during the Giveaway Period will be combined and one (1) potential prize winner will be selected in a random drawing on or about August 21, 2026. All entries are non-transferable. The potential prize winner will be notified using the email address and phone number provided with entry on or around August 21, 2026, and may be awarded the prize subject to verification of eligibility and compliance with the terms of these Official Rules. Failure by the potential prize winner to respond within seventy-two (72) hours of notification and after the second of two (2) attempts will result in disqualification and an alternate potential prize winner then will be selected in the same manner, from all remaining eligible entries. If Vitalant is unable to determine and verify a potential prize winner after repeated alternate drawings, Vitalant reserves the right to not award all prize(s) or all elements of the Prize. No prize in the giveaway will be given in cash or may be redeemable or convertible into cash. The prize winner of this Rev Up the Excitement Summer Car Giveaway is not eligible to win the prize in Vitalant's local Arizona Summer Drive to Save Lives Giveaway. From the date of the winner's acceptance of the prize, the winner has thirty (30) business days to select a vehicle from the dealership of their choice. The winner's failure to select a vehicle within this timeframe may result in forfeiture of the prize.

Noncompliance with any of the foregoing may result in disqualification and the selection of an alternate prize winner name. Vitalant reserves the right to permanently disqualify any person who it believes has intentionally violated these Official Rules.

Miscellaneous: The odds of winning depend upon the number of eligible entries received according to the eligibility requirements. By entering, participants agree to be bound by these Official Rules and decisions of Vitalant. By participating in the giveaway, participants agree to release and hold Vitalant and their employees harmless from any and all losses, damages, rights, claims and actions of any kind in connection with the drawing or the giveaway, or resulting from acceptance, possession or use of any prize, including without limitation, personal injuries, death and property damage, and claims based on publicity rights, defamation or invasions of privacy. Vitalant reserves the right to change these Official Rules without notice. The conduct of this giveaway is governed by the applicable United States laws, which take precedence over any rule to the contrary herein. Vitalant will follow the applicable laws for conducting a giveaway. The prize winner's name will be published on Vitalant's blog (vitalant.org/blog) within ninety (90) days after the conclusion of the giveaway.
